

## ComEd "Switch on Summer" 2022 Sweepstakes Rules

The ComEd® "Switch on Summer" Sweepstakes. NO PURCHASE NECESSARY. Making a purchase will not improve your chances of winning. Internet Access Required. This Sweepstakes is not sponsored, endorsed or administered by, or associated with, Facebook, Twitter or Eloqua. Facebook, Twitter and Eloqua are not affiliated with the Sponsor in any way. 1. Sweepstakes Period: The ComEd "Switch on Summer" Sweepstakes (the "Sweepstakes"), sponsored by Commonwealth Edison Company ("Sponsor"), begins at 9:00:00 a.m. Central Time ("CT") on April 11, 2022 and ends at 11:59:00 p.m. CT on April 27, 2022 (the "Sweepstakes Period"). 2. Eligibility: The Sweepstakes is open to legal residents in ComEd service territory who are 18 years of age or older as of date of entry. Employees, officers and directors of Sponsor, its affiliates, parent company, subsidiaries, divisions, suppliers, distributors and advertising, promotional and judging agencies, and members of the immediate families (spouse, biological, adoptive or step-parents, grandparents, children, grandchildren and siblings, and each of their respective spouses, regardless of where they reside or households, whether related or not) of any of the above are not eligible to participate in the Sweepstakes. Void outside Illinois and where prohibited by law. The Sweepstakes is subject to all applicable federal, state and local laws. 3. How to Enter: During the Sweepstakes Period, you may enter the Sweepstakes through the Sweepstakes application on the ComEd "Switch on Summer" contest webpage at <http://marketing.comed.com/SwitchOnSweepstakes2022> (the "Site"). To enter, follow all prompts and instructions on the Site to register, answer a designated multiple-choice question, and follow all prompts and instructions to submit your entry. Your answer, once received by Sponsor, will be referred to herein as your "Entry". There is a limit of one (1) Entry per person for the entire Sweepstakes Period. By entering, you understand that your Entry, in whole or in part, may (in Sponsor's sole discretion) be posted on websites, the Site, other social media sites and/or other Sponsor selected media. All Entries must be received by 11:59:00 p.m. CT on April 27, 2022. Normal Internet access and usage charges imposed by entrants' online service providers will apply. Automated, script, macro or robotic Entries, or Entries by more than one person or by organizations, will be void and disqualified. By entering, you agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which shall be final in all Sweepstakes related matters. 4. Drawing: On or about April 28, 2022, the Sponsor will conduct a random drawing from among all qualifying Entries received to select one (1) potential winner, who will receive the prize described in Rule 5, below (subject to verification of eligibility). The odds of winning the prize depend on the number of eligible Entries received. 5. Prize: The verified winner will have the opportunity to turn on the lights illuminating Buckingham Fountain in an official ceremony at the ComEd "Switch on Summer" event (the "Event") to be held at Buckingham Fountain or virtually (pending winner and/or sponsors preference that will be confirmed prior to event date) on May 14, 2022 at approximately 2:00 P.M.CT. All costs associated with attendance at the Event, including but not limited to transportation and parking, are the sole responsibility of the winner. The prize has no retail value. If the event is in-person, the winner agrees to comply with health-related requirements and must be present at the Event site by 12:00 p.m. CT on May 14, 2022 or s/he may forfeit the prize, in the discretion of the Sponsor. If it is a virtual event, the winner must provide a pre-recorded video a week prior to the event. By accepting the prize, the winner agrees that Sponsor or its agents may photograph and/or videotape or film any or all aspects of the Event (referred to herein as "Footage") and that Sponsor may use or edit such Footage in any way it sees fit, including but not limited to using it in/on all Sponsor-related web sites, social media, and television. In the event the winner engages in behavior that (as determined by Sponsor in its sole discretion) is inappropriate or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate

the winner's participation in the Event. Potential prize winner understands and agrees that, as a condition of being awarded the prize, he/she may be subject to a background check at the sole discretion of Sponsor; failure to comply may result in disqualification and forfeiture of prize. In addition, at the discretion of the Sponsor, potential winner may be disqualified if: (a) charged with or convicted of a felony or misdemeanor; (b) Sponsor determines, in its sole discretion, that awarding the prize to such individual may reflect unfavorably on the Sweepstakes or Sponsor; (c) potential winner is not eligible to receive the prize based on the eligibility requirements set forth in these Official Rules; (d) Sponsor determines that potential winner failed to comply with these Official Rules in any way; or (e) potential winner refuses to or cannot accept the prize for any reason. By accepting the prize, the winner acknowledges that the Sponsor is under no obligation to use his/her image in any way.

Potential prize winner will be notified by email and/or phone call and will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release within forty-eight (48) hours of initial notification or the prize will be forfeited and may be awarded to an alternate winner (time permitting) in a random drawing from among the remaining Entries. Alternate winner (if any) will be subject to the prize claim requirements described above. Return of prize notification as undeliverable may result in prize forfeiture and the selection of an alternate winner in the manner described above (time permitting). The Released Parties are not responsible for: (a) electronic transmissions or Entries that are lost, late, stolen, incomplete, damaged, garbled, destroyed, misdirected or not received by Sponsor or its agents for any reason; (b) any problems or technical malfunctions, errors, omissions, interruptions, deletions, defects, delays in operation or transmission, communication failures or human error that may occur in the transmission, receipt or processing of Entries, or for destruction of or unauthorized access to, or alteration of, Entries; (c) failed or unavailable hardware, network, software or telephone transmissions, damage to entrants' or any person's computer and/or its contents, or causes beyond Sponsor's reasonable control that jeopardize the administration, security, fairness, integrity or proper conduct of this Sweepstakes; (d) incorrect or inaccurate entry information whether caused by entrants or by any of the equipment or programming associated with or utilized in the Sweepstakes; (e) any typographical or other error in any printing or advertising related to this Sweepstakes, in the administration or execution of the Sweepstakes, or in the announcement of the prize winner; or (f) cheating or fraud by any entrant. All incomplete or non-conforming Entries will be disqualified. The Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the Sweepstakes entry process or the operation of the Sweepstakes, violates the Official

Rules, or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and should such an attempt be made, Sponsor reserves the right to disqualify and seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. If, for any reason, the Sweepstakes is not capable of running as planned, including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Sponsor that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, then the Sponsor reserves the right at its sole discretion to terminate the Sweepstakes and determine the winner in a random drawing from among all eligible, non-suspect Entries received prior to the time/date of termination.

7. Disputes/Venue/Governing Law: By participating, all participants agree that: (a) any and all disputes, claims and causes of action arising out of, or connected with, this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Cook County, Illinois; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including but not limited to costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (c) to the extent allowed by applicable law, under no circumstances will participant be permitted to obtain awards for, and participant hereby waives, all rights to claim punitive, incidental and/or consequential damages and/or any other damages, other than out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any participant or Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the internal laws of the State of Illinois without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials or notifications and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern and control.
